



ASCUTNEY MOUNTAIN EQUINE PLEASURE RIDE
CO-SPONSORED BY VERDA AND ASCUTNEY OUTDOORS
SATURDAY, OCTOBER 9, 2021 at 9:30 a.m.

Please join us for the third annual pleasure ride on Mount Ascutney cosponsored by VERDA and Ascutney Outdoors. The trail is approximately 9.0 miles with an optional shorter loop of 6.5 miles, on beautiful Mount Ascutney and surrounding area, mostly on woodland trails and some road. Lunch and soft drinks will be provided.

Ride briefing will be emailed to you. Trail opens at 9:30 a.m.

Entry Requirements: No entries will be accepted at the ride. Entries (with Coggins and rabies certificates) must be mailed by no later than October 2. ASTM SEI approved helmets must be worn by riders. Waivers must be signed by all riders and parent or guardian of Juniors (under 18 years of age).

Covid 19 Requirements: We will be following State of Vermont regulations re Covid-19 in effect at the time of the ride. Please bring your own mask and respect social distancing. If you feel sick or have lost sense of smell or taste please do not attend, go see your doctor.

Directions: Ascutney Outdoors Center – 449 Ski Tow Road, Brownsville, Vermont 05037. Ascutney Outdoors Center is just 15 minutes from Interstate 91.

From the North, take Exit 9 onto Rte 5 South through Windsor, then turn right onto Rte 44 West to continue toward Brownsville.

From the South, take Exit 8 to Rte 5 North then veer left to Back Mountain Rd (Rte 44A) to Rte 44 West toward Brownsville. Turn left onto Ski Tow Road – look for Ascutney Outdoors and Trails signs.
