Time: Saturday morning vetting begins at 6:30 AM sharp (if enough entries, some vetting Friday afternoon).

Trail: The trail will be dirt roads, and some trail.

Farrier: Bring an easy boot(s)

Food: Breakfast snacks and coffee before ride. **POTLUCK at KVS during and after final vetting.**

Rules: **Dogs must be on leash at all times.** NO Dogs preferred. Hay, shavings and manure must be picked up. All ECTRA rules and regulations apply. ECTRA rules require that all riders wear an ASTM-SEI approved helmet.

Stabling: Stalls are available please contact KVS for prices and stalls. 802-457-1480.

Entry Requirements: Negative coggins test and proof of rabies vaccine is required with entry.

Refunds: All refunds will be made to any competitor if request is made earlier than Nov 1st. Make checks payable to **VERDA** and send entry to: Jenny Kimberly, 221 Estey Lane, Windsor, VT 05089

PARKING: Limited parking we will try to get as many trailers as possible at KVS, PLEASE try to truck with a friend. Otherwise we must park your trailer at GMHA, come back with your truck or have someone bring you back.

Directions

From the south: take I-91 north to exit 8, end of ramp turn left, this is RTE 131, it is a much better road. Follow RTE 131 (about 7 miles) to RTE 106 (Downers Corners). Turn right on 106 and follow it about 14 miles, past GMHA and through village of South Woodstock. About ½ mile from South Woodstock Kedron Valley Stables will be on the left.

From North: Take exit 1 on I-89 and head west on RTE 4 to Woodstock. In Woodstock go around the green and go south on RT 106 about 4.3 miles. Just before South Woodstock Kedron Valley Stables is on the right.

From the West: get to Downers Corners (RTE 106 & 131) from RTE 10 to 106, or RTE 11 to 106. At Downers Corners get on 106 north and follow it about 14 miles, past GMHA and through village of South Woodstock. About ½ mile from South Woodstock Kedron Valley Stables will be on the left.

From the East: get on I-89 or 91 and follow directions above.
